NOTICE OF ENFORCEMENT OF EXILE

ENFORCEMENT
AUTHORIZED

Mr. Said,

This office is in receipt of your Letter of Contrition and Voluntary Exile, dated 18 July 2026, in which you confess to the knowing and repeated slowing of the website and sentence yourself to exile upon the Island of Elba until the slow loading and deploys are completely resolved. In my capacity as Chief Operating Officer of RMH Studios and Chief Executive Officer of RMH Private Military Contracting, I write to inform you that your sentence has been reviewed, accepted, and — effective immediately — **placed under enforcement**.

A voluntary exile, left to the goodwill of the exiled, is merely a vacation. RMH does not deal in vacations. Accordingly, the terms below shall govern your stay upon Elba until the metrics turn green.

1. ENFORCEMENT AUTHORITY

Enforcement of this exile is hereby assigned to the **RMH PMC Department of the Navy, Maritime Enforcement Command**. A standing detachment of Naval contractors shall be posted to the waters and shores of Elba for the full duration of your sentence. Patrol craft will maintain a perimeter; the harbor will be watched; the olive groves will be walked. Their orders are simple and their professionalism absolute.

2. CONDITIONS OF CONFINEMENT

1. You shall not depart the Island of Elba by sea, air, or optimism.
2. Any attempted "return of a hundred days," as pledged against in your letter, shall be intercepted at the waterline by our Naval detachment.
3. You shall retain full internet access for the sole and exclusive purpose of fixing the website. This is a work-release, not a mercy.
4. Daily performance reports shall be submitted to this office. Latency will be measured. Excuses will not be logged.

3. CONDITIONS OF RELEASE

The RMH PMC Naval detachment shall stand down, and you shall be released from Elba, only upon written verification by this office that: every page loads with haste; every deploy completes cleanly and swiftly; Time to First Byte is a source of pride; and no user waits upon your negligence again. Until all four conditions are met and verified, the perimeter holds.

4. REPARATIONS

Your pledged reparations — three (3) Claude Max 20× licenses — are noted, accepted, and expected in full. RMH PMC will confirm receipt. Non-payment extends the sentence.

You brought yourself to Elba, Mr. Said. We are simply here to make sure you stay until the work is done. Fix the website, and the sea is yours again.
