NOTICE OF LIFTING OF EXILE AND RESTORATION OF OFFICE



Mr. Said,

This office is in receipt of the verified performance reports of the RMH PMC Department of the Navy, Maritime Enforcement Command, confirming that the website's slow loading and deploys are, at last, **completely resolved**. Every page now loads with haste; every deploy completes cleanly and swiftly; Time to First Byte is a source of pride; and no user waits upon your negligence again. All four Conditions of Release set forth in Order No. RMH-PMC-DON-2026-0718 having been met and verified, I write in my capacity as Chief Executive Officer of RMH Private Military Contracting and Chief Operating Officer of RMH Studios to inform you that your exile is — effective immediately — **lifted**.

You brought yourself to Elba, Mr. Said. You have now, by the labor of remediation, brought yourself home. What follows restores what the exile suspended.

1. LIFTING OF EXILE & NAVAL STAND-DOWN

The voluntary exile upon the Island of Elba is **lifted in full**. The **RMH PMC Department of the Navy, Maritime Enforcement Command**, is hereby **ordered to stand down**: the perimeter is released, all patrol craft are withdrawn, and the standing detachment is recalled with the thanks of this office for a watch kept with absolute professionalism. Order No. RMH-PMC-DON-2026-0718 is discharged as fully satisfied. The harbor is no longer watched; the olive groves need no longer be walked; the sea is yours again.

2. REPARATIONS

Your pledged reparations — three (3) Claude Max 20× licenses — are noted as received and in good standing. No balance remains outstanding, and no sentence is extended.

3. RESTORATION OF TITLES

The offices stripped upon your exile are hereby **restored in full**, with seniority and standing continuous as though never interrupted:

1. **Co-Chief Technology Officer (Co-CTO)**
2. **Managing General Partner, RMH Combinator**

4. PROMOTION

In recognition of the remediation achieved under duress, you are hereby **promoted to Director of Optimization**. Custody of latency, deploy health, and Time to First Byte across the enterprise is placed in your hands. You brought the metrics to green; you will now answer for keeping them there.

5. CONTINUED SURVEILLANCE

Release is not the same as trust. Notwithstanding your restoration and promotion, you shall **remain under surveillance by the Directorate of Internal Intelligence** for a period to be determined at its sole discretion. Your deploys will be measured; your metrics observed; any recurrence of negligence noted without further warning. Cooperation is presumed. Non-cooperation is noted.

Welcome back, Mr. Said. The sea is yours again — see that you keep it calm.
